CONSTITUTION OF INDIA

No.GG/33/2009/MKM/102007/267(PT-7)/E-1. In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating the recruitment to the post of Prohibition Propaganda Officer, Class III, in the subordinate service of the Directorate of Prohibition and Excise, Gujarat State, namely:-

- 1 These rules may be called the Prohibition Propaganda Officer, Class III, Recruitment Rules, 2009.
- 2 Appointment to the post of Prohibition Propaganda Officer, Class III, in the subordinate service of the Directorate of Prohibition and Excise, Gujarate State shall be made either,
  - (a) by direct selection;
  - (b) by direct selection from amongst the persons who have worked as Jilla Niyojak or City Niyojak in or under the Gujarat Rajya Nasabandhi Mandal or
  - (c) by temporary transfer on deputation basis from amongst the persons working in the subordinate service in any other department of the State Government and who possess the educational qualifications as prescribed in clause (b) of rule 3 for direct selection.
- 3 To be eligible for appointment by direct selection referred to in clause (a) of rule 2 for the aforesaid post candidate shall,
  - (a) not be more than 30 years of age;
  - (b) Possess a degree in Social Welfare obtained from any of the University or an institution established or incorporated by an Act of the Parliament or aState legislature in India or an institution declared to be deemed as University under section 3 of the University Grants Commission Act,1956 (3 of 1956) or an equivalent qualification recognized as such by the Government;
  - (c) possess the basic knowledge of Computer application inaccordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;
  - (d) possess adequate knowledge of Gujarati and/or Hindi:

Provided that preference may be given to a candidate who has good knowledge of social activities and shall have special knowledge of prohibition policy and family welfare programmes of Government:

Provided further that the upper age limit may be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967.

- 4 To be eligible for appointment by direct selection referred to in sub-rule (b) of rule 2, a candidate shall,
  - (a) not be more than 45 years of age;
  - (b) possess a degree obtained from any of the University or an Institution established or incorporated by an Act of the Parliament or a State Legislature in India or an institution declared to be deemed as University under section 3 of the University Grants Commission Act, 1956 (3 of 1956) or an equivalent qualification recognized as such by the Government;
  - © possess the basic knowledge of computer application in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;

- (d) have experience of not less than five years as Jilla Niyojak or City Niyojak in or under the Gujarat Rajya Nasabandhi Mandal;
- (e) possess adequate knowledge of Gujarati and/or Hindi.
- 5 A candidate appointed by direct selection shall be on probation for a period of one year.
- 6 A candidate appointed by direct selection shall during his probation period be required to pass the qualifying examination for Computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006.
- 7 The selected candidate shall be required to pass an examination in Hindi or Gujarati or both in accordance with the rules prescribed by the Government from time to time.
- 8 A candidate appointed by direct selection shall have to undergo such training and to pass such examination as may be prescribed by the Government.
- 9 A selected candidate shall be required to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Government in that behalf.
