**No.GK/17/2020/PRCH/102020/UOR-10/D** :- In exercise of the powers conferred by sub-section (1) of section 157 read with clause (o) of section 2 of the Code of Criminal Procedure, 1973 ( 2 of 1974) ( hereinafter referred to as the "Code") in its application to the State of Gujarat , the Government of Gujarat hereby empowers, notwithstanding anything contained in any rules or instructions, the officer in charge of the police station to deputy any subordinate in the rank of police constable (Unarmed) having five years regular service to investigate cases having maximum punishment prescribed as five years imprisonment, with or without fine, and to perform such functions necessary for conducting the investigation under Chapter XII of the code, as well as appearing in any court, and carrying out all other function as required for investigation and trial of cases.
